- (i) the deployment of fire and police services and staff
- (ii) the development and implementation of emergency plans

- [] 12. To conduct or discuss and investigative proceeding on actual or possible criminal conduct;
- [] 13. To comply with a specific constitutional, statutory or judicially imposed requirement that prevents public disclosures about a particular proceeding or matter;
- [] 14. Before a contract is awarded or bids are opened, discuss a matter directly related to a negotiating strategy or the contents of a bid or proposal, if public discussion or disclosure would adversely impact the ability of the public body to participate in the competitive bidding or proposal process.
